Investigation Recording 31, all the Political and Legal Affairs Commission officials above the division level are privy to the issue of live organ harvesting of Falun Gong practitioners.

From September 16 to 26, 2008, a Political and Legal Affairs Commission (PLAC) national meeting was being held in Jiangnanchun Hotel, Changzhou City, Jiangsu Province. A WOIPFG investigator, posing as “an official from the Ministry of National Security” conducted a phone investigation on one of the meeting participants, Mr. Li, who’s a staff member of the PLAC system in Beijing, during this period of time.

Phone Investigation Recording

Investigator: Is that Jiangnanchun Hotel?

Operator: Ah, yes.

Investigator: Please put me through to Comrade Li from Beijing’s PLAC system. His extension is 1219.

Operator: You are calling from inside the hotel, right?

Investigator: No, from outside.

Operator: Okay.

Li: Hello.

Investigator: Hello, is that Comrade Li from the Central PLAC?

Li: Hello.

Investigator: Is that Comrade Li?

Li: Where are you calling from?

Investigator: Your family name is Li?

Li: That’s right.

Investigator: I’m calling from the Ministry of National Security. We need your assistance regarding an issue.

Li: From the Ministry of National Security?

Investigator: Yes.

Li: How may I help you?

Investigator: We are investigating a case of a state secret leakage.

Li: What state secret was leaked?

Investigator: Well, we want to know which levels of officials from your PLAC system are familiar with a certain state secret.

Li: What is this about?

Investigator: This is regarding the state secret of live organ harvesting from Falun Gong practitioners for organ transplant operations. Which levels of officials of the PLAC are privy to this state secret?

Li: Should be all the levels above the division level.

Investigator: We obtained our information through wiretapping that a staff member of the PLAC wants to sell this state secret to foreign intelligence agencies, so our higher-ups instructed us to secretly conduct this investigation.

Li: I understand.

Investigator: We want to conduct a small-scale investigation. We don't want to disturb a lot of people.

Li: Ah, okay. You can do this. You make another phone call and ask for a division director surnamed Liu. He is the one who is organizing a class. Yes, go ask him.

Investigator: He is?

Li: I don't know his phone number.

Investigator: Ah.

Li: OK?

Investigator: Ah, what's his name?

Li: You can ask the operator to transfer you. It's Director Liu.

Investigator: Director Liu?

Li: He has been overseeing this class and has been organizing events regarding this in this hotel.

Investigator: Ah.

Li: There is also a director, whose family name is Wei (the investigator later found out that his full name is Wei Jianrong), from the Instruction Room of the PLAC Team Development. He has been here for the past several days.

Investigator: Ah, okay.

Li: And Director Liu has been overseeing the class onsite. I'm not sure about his full name. You can continue your investigation. Good luck.
