## Notice to Investigate the Deputy Director of "China Anti-Cult Association" Sheng Hui

Published in Chinese on Oct. 27, 2005; Translated into English on Sept. 3, 2012

Sheng Hui, also known as Sheng Qinghui, was born on Nov. 23, 1952 in Xiangtan City, Hunan Province. Sheng Hui is the deputy director of the so-called "Anti-Cult Association" (referred to as "cult association" hereafter), member of the National Political Consultative Standing Committee, vice president of the Buddhist Association of China and the vice dean of the Chinese Buddhist Academy.

Since Jiang Zemin started persecuting Falun Gong on July 20, 1999, Sheng has been following Jiang and using his positions at the National Political Consultative Standing Committee and various religious organizations to repeatedly publish slanderous and defamatory remarks about Falun Gong and the founder of Falun Gong. He gave many suggestions to the regime and its "610 Office" system. He has been directly involved in the persecution of Falun Gong practitioners. He participated in many conferences that were specifically designed to slander Falun Gong. He spoke at the United Nations General Assembly on Human Rights and the Chinese People's National Political Consultative Conference; He wrote over ten thousand words to attack Falun Gong. His hate-provoking speeches were quoted by the regime's mouthpiece media, such as Xinhua News Agency, People's Daily and China Central Television (CCTV). These reports misled public opinion and exported hatred and added fuel to the persecution of Falun Gong. By the time of this report, at least 2,757 Falun Gong practitioners have been persecuted to death. Evidence of Sheng's public defamatory reports and speeches include:

He participated in a forum on Aug. 2, 1999. The forum was organized by the Buddhist community and designed to slander Falun Gong; He was interviewed by BBC in the United States on Aug. 25, 2000; On Jan. 31, 2001, he participated in a religious forum in Hunan Province. In Feb. 2001, he was interviewed by Xinhua News Agency. He also participated and gave speeches at various forums including: the second China "Cult Association" colloquium held in Beijing on Feb. 28, 2001, the

fourth Session of the ninth CPPCC National Political Consultative Conference on March 9, 2001 and the slanderous forum organized by the "Cult Association" delegation in Geneva on March 23, 2001. He was interviewed by People's Daily on April 2, 2001. He gave a speech at United Nation's 57th session of the Commission on Human Rights and the ninth National Public Consultative Committee on March 4, 2002. He hosted the "Cult Association" Fifth Colloquium on April 25, 2002. He gave a speech to slander Falun Gong on May 7, 2002 in Hong Kong. On May 22, 2003, he participated in the symposium organized by the regime in refuting the annual report of the U.S. international Religious Freedom Commission. On July 22, 2003, he attended a forum organized by the religious community. In addition, he published an article with over ten thousand words on Nanputuo Journal to attack Falun Gong and its founder. The article was reprinted by many other medias.

For the above reasons, the World Organization to Investigate the Persecution of Falun Gong (WOIPFG) will start to investigate Sheng Hui. According to the case law, in December 2003, the International War Crimes Tribunal for Rwanda trialed three men for using media to incite hatred and demonize victims. Two were sentenced to life imprisonment and the other to 35 years in prison. The WOIPFG have presented the evidence to international courts, human rights organization and the International Special Tribunal to Bring CCP to Justice – Sydney Tribunal. The WOIPFG will prosecute and expose Sheng's illegal activities in persecuting Falun Gong. According to the "Anti-Atrocity Alien Deportation Act" (see appendix), the WOIPFG will submit Sheng's criminal records to each country's department of customs and immigration.

This organization welcomes insiders to collect evidence (including text, pictures, audio files and video files) as well as evidence on his corruption and possession of illegal assets overseas and to submit the evidence through a safe and reliable channel.

## The Anti-Atrocity Alien Deportation Act

On Dec. 17, 2004, US President George W. Bush signed in Washington DC, a bill authorized the Department of Justice to track foreigners who have committed war crimes, torture, genocide, persecution of religious beliefs and violations of human rights, and to restrict their entry or to have them removed. Under the new bill, those who have once tortured others, committed crimes of genocide or persecuted religious believers, are not allowed to enter the United States and should be removed from the United States. The bill also expanded reasons of prohibited entry and deportation: foreigners who are involved in (1) torture and murder abroad; (2) "genocide" and "particularly severe violations of religious freedom". The U.S. Immigration and Naturalization Act Section 212 (a) (2) (G) states that foreign government officials who have been involved in serious violations of religious freedom in the past two years, they and their families and children are not allowed to enter the United States.
